The draw will be held at the home of the Field trial Secretary at 5949 Chadsey Rd Chilliwack BC V2R 4P2. Please send one entry per dog running in the trial. Entry Fees **MUST** be in Canadian Funds. A listing fee of \$9.41 must accompany each entry for those dogs not registered in Canada, or for those dogs that do not hold an Event Registration Number. CKC registration or ERN must be applied for within 30 days of the trial or all wins and awards will be cancelled. Application forms are available from the CKC at the above address or online at www.ckc.ca. Refunds must be requested in writing and must be accompanied by a veterinarian's certificate. Make all fees payable to the BCLRC (1995).

Please note "New CKC Ruling": Canadian Residents non CKC Members running a wholly owned dog cannot win a placement unless they pay a non-member participation fee or a membership fee to the CKC.

Dead ducks will be used in this trial.

Male and Female dogs will be run in order of the draw.

Female dogs will not be vetted and handlers are reminded that bitches in estrus cannot compete in a CKC licensed Trial.

Starting dog in the Open and Amateur stakes will be determined by the TSX closing on Wednesday May 10th, 2016.

A system of rotation will be used for the start of subsequent series in the All Age Stakes.

Wingers may be used in all stakes.

CKC Rules and Regulations 21.7

It shall be the duty and obligation of the trial-giving club that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Retriever Field Trial committee Chair shall promptly report to the CKC any infringement of the regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that an infraction has occurred.
