### PAYMENT:

- **Entries not accompanied by payment (cheque or e-Transfer) will NOT be accepted**
- Electronic Transfer (e-Transfer) can be sent to email address – [treasurer.eorc@gmail.com](mailto:treasurer.eorc@gmail.com)
- Make cheques payable to the Eastern Ontario Retriever Club (EORC), dated no later than Monday, May 15, 2017
- A \$9.61 listing fee must accompany any entry form for dogs without an individual C.K.C. registration or ERN
- Separate entry forms must be completed for each stake the dog is entered.
- Scratches/refunds for dogs withdrawn after the closing date, for reasons other than stated in the C.K.C. Retriever Field Trial rule book, will not have their entry fees refunded
- All fees to be in Canadian funds, no exchange will be given on U.S. funds.

**RUNNING ORDER:** The starting dog in the first series of Open and Amateur will be determined by using the last two digits at closing of the Toronto Stock Exchange (TSE) S&P/TSX composite index on the Thursday immediately preceding the trial. At the Judge's discretion, there will be a rotation of running order in all of the stakes.

**GAME:** Dead ducks and/or pheasants will be used in all stakes

### POINTS and RIBBONS:

- Placings and points awarded are as follows: First-5, Second-3, Third-2, Fourth-1
- Standard C.K.C. rosettes to the first four placings and certificates of merit (CM) in each stake
- Ribbons will be presented at the tailgate

**HEADQUARTERS:**

- Westport Station Motel, 52 Concession St., Westport, ON, Canada, K0G 1X0
- **NOTE: EORC is no longer using the Cumpson Farm. There is no camping available on any of the grounds. Please do not contact the Cumpsons for Camping or airing.**
- The Stakes will be signed from the Westport Station Motel

**DIRECTIONS:**

- From west of Montreal, east of Toronto, or south-west of Ottawa: Take Division St. Exit 617 off 401 at Kingston and head north. At the end of the road, turn left to get to the Westport Station Motel.
- From Ottawa via Hwy 7: Take County Rd 36 in the town of Maberly, west of Perth, and east of Sharbot Lake and follow the signs to Westport.

**TAILGATE:**

- There will be a tailgate on Saturday, May 20 after the trial.

- Please note new C.K.C. Ruling: Canadian Resident non C.K.C. Members running a wholly owned dog cannot win a placement unless they pay a non-member fee to the C.K.C. otherwise, awards & titles will be cancelled".
- Field Trial Rule 21.7: "It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Retriever Field Trial Committee Chair shall promptly report to the C.K.C. any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred".
- The Eastern Ontario Retriever Club is a member of the National Retriever Club of Canada. Dogs entered in all age stakes may qualify for the National Stakes.
