**Running Order:** We will utilize the 2 ending digits in the TSX as of the close of business on Tuesday, May 9, 2017 as a starting number for the first series in the all age stakes. Judges will impose a system of rotation thereafter in the all age stakes. Dogs will run in order of the draw with sexes mixed. Running order will rotate in the Open & Amateur stakes.
