Attention U.S. entrants: Personal cheques must be made out for the full amount in Canadian Funds. DO NOT WRITE 'CANADIAN FUNDS' OR 'AT PAR' ON THE CHEQUE, as this is not acceptable at the bank and will be returned. Bank drafts or money orders must be in Canadian Funds.

A listing fee of \$9.41 must accompany each entry for those dogs not registered in Canada, or for those dogs that do not hold an Event Registration Number. CKC registration or ERN must be applied for within 30 days of the trial or all wins and awards will be cancelled. Application forms are available from the CKC.

Bitches in season may not compete and must be withdrawn. Entry and listing fees paid for any dog withdrawn because of estrus, injury, illness or death shall be refunded in full. An appropriate veterinary certificate must be given to the F.T. Secretary before the start of the stake to qualify for a refund.

Starting dogs will be determined by the TSX closing on Thursday, May 18, 2017 and the running order will be posted prior to commencement of the trial. A rotation system will be used for the start of subsequent series.

These events held under the rules of The Canadian Kennel Club.

It is the duty of every CKC club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities. The Retriever Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation and the CKC shall have the authority to take such action as it sees fit on receipt of a report indicating that this has occurred.

Dead ducks will be used at each stake.
