- Signed original and entry fees must be delivered within one hour of the commencement of the trial.
- A temporary competition fee as established by The Canadian Kennel Club must accompany the entry of a dog for which a Canadian Kennel Club individual registration number or Event Registration Number (ERN) is not shown on the entry form. **Temporary Competition Number (TCN) must be applied for (online, paper application, or contact Show & Trials Division CKC 1-855-364-7252), BEFORE SUBMITTING AN ENTRY FEE FOR AN EVENT. The same TCN must be used for all event entries until the dog is permanently registered.**
- Entry Forms must be completed in full and accompanied by ENTRY FEES AND, if applicable **\$10.50 Temporary Competition Fee.**
- Please Note CKC Ruling: Canadian Resident non CKC Members running a wholly owned dog cannot win a placement towards awards unless they pay a non-member participation fee or a membership fee to the CKC. CKC Registration or ERN must be applied for within 30 days of the trial or all awards will be cancelled.
- All participants must be familiar with CKC Rules and Regulation 21.7: In summary, it provides that any Person participating in a Trial shall not be subjected to an indignity of any kind. Violations of this rule shall be dealt with in accordance with the rules and regulations of the Canadian Kennel Club.
- Males and Females will be run in the order of the draw. Bitches in season may not compete and must be withdrawn.
- Any dog not appearing within 15 minutes of its time to run may be disqualified.
- Dead Ducks will be used in all stakes.
- Standard CKC Rosettes will be awarded.

#### **RELEASE AND INDEMNIFICATION OF LANDOWNERS:**

By entering this Trial each participant agrees to assume all risks and hazards incidental to participation in the Trial and agrees to release and save harmless and indemnify the owner(s) of any property upon which the Trial is held together with their officers, agents, employees and representatives from all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to the person or property of the participant howsoever caused, arising out of or in connection with the participants use or entry upon the property. It is understood that this agreement is binding upon the participants, his or her heirs, executors and assigns. **ALL PARTICIPANTS MUST SIGN THE ATTACHED WAIVER.**

**REFUNDS:** Full refunds will be given for any dog withdrawn because of estrus, injury, illness or death. Other refunds (less a scratch fee of \$10.00 per dog) may be given for good cause at the discretion of the field trial committee. All requests for refunds must be in writing and must be received within 2 days of the last day of the trial and, unless otherwise agreed by the field trial committee, must be accompanied by a Veterinarian's certificate.

- **There is no lunch wagon on site. Closest amenities are in Black Creek, Merville or Courtenay.**

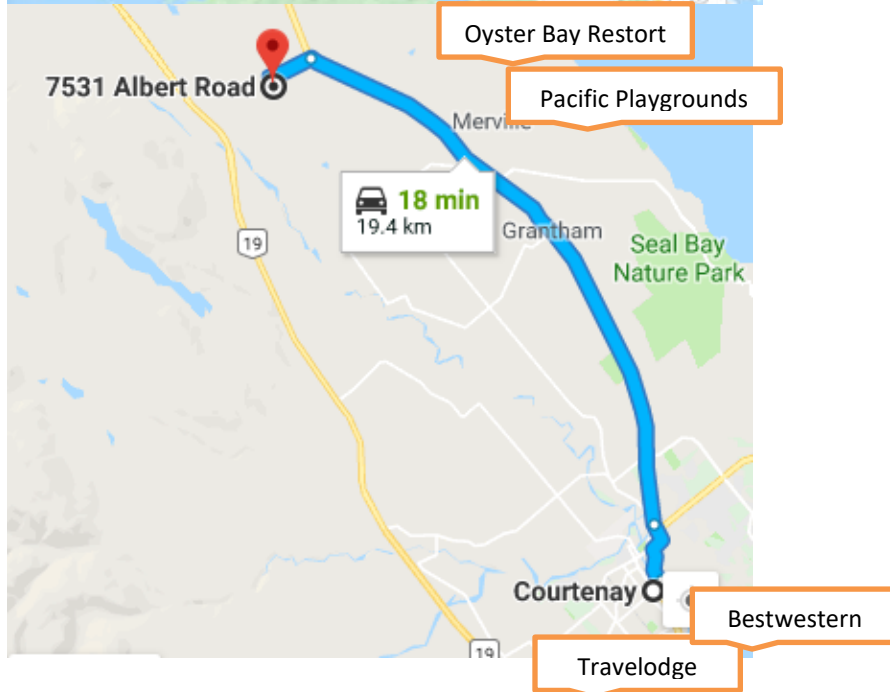
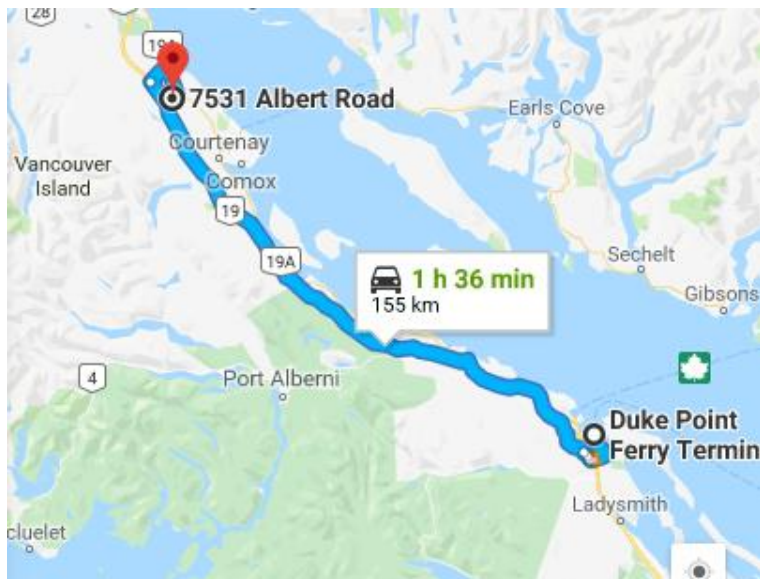

## 2021 Swamp Dog Farm Waiver and Release Agreement

BY SIGNING THIS RELEASE AGREEMENT, YOU WAIVE OR GIVE UP CERTAIN LEGAL RIGHTS INCLUDING THE RIGHT TO SUE OR CLAIM COMPENSATION AS THE RESULT OF AN ACCIDENT AND/OR INJURY.

BY SIGNING THIS RELEASE AGREEMENT, YOU AGREE TO INDEMNIFY SWAMP DOG FARM, its owners Kathy Miner & Barbara Loree, employees, instructors, farmers, representatives, contractors, subcontractors, suppliers, sponsors, successors and assigns (all of whom are hereinafter referred to as "the Releasees").

THIS DOCUMENT MAY BE USED AGAINST YOU IN A COURT OF LAW.

**YOU MAY NOT PARTICIPATE IN ANY ACTIVITY AT SWAMP DOG FARM UNTIL YOU HAVE SIGNED THIS RELEASE.**

## **DEFINITION**

1. In this Release Agreement, ACTIVITIES AT SWAMP DOG FARM includes all activities, events or services provided, arranged, organized, conducted, sponsored or authorized by the Releasees and includes, but is not limited to: dog training, dog events, dog instructional courses, classes, workshops, seminars, hunting, use of firearms, hunting bow, discharge of firearms and starter pistols, rental and/or use of dog training equipment including propulsion equipment, wingers, launchers, transport of people and/or dogs in vehicles, transport of training equipment in vehicles, ATV and watercraft of all shapes and sizes, handling of birds, food preparation, storage and distribution, indoor and outdoor meetings, indoor and outdoor training, site and training area clean-up events, social events, site and area clearing, preparation, excavation, farming and use of farm equipment. (the "Activities").

## **ASSUMPTION OF RISKS**

2. I am aware that the Activities involve many risks, dangers and hazards including, but not limited to: injury to myself, my dog, accidents that occur while traveling and training with dogs, slips and falls while walking or running in outdoor terrain, roads, fields, indoor areas, loss of balance resulting in injury including physical impact from vehicles, ATV's, farm equipment, training equipment, my dog, other participants dogs, wildlife, trees, rocks, holes in ground and other environmental hazards, physical injury, trauma, illness from wildlife, insects, water immersion, changing and inclement weather conditions including storms, high winds, heat, cold, severe social and economic losses which might result from my own actions, my dog's actions, inactions or negligence, the actions, inactions or negligence of others or others dogs, or THE ACTIONS, INACTIONS OR NEGLIGENCE ON THE PART THE RELEASEES, INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS KNOWN, NOT KNOWN, OR NOT REASONABLY FORESEEABLE AS AT THE DATE HEREOF, THAT MAY OCCUR WHILE PARTICIPATING IN THE ACTIVITIES.
3. I AM AWARE OF THE RISKS, DANGERS AND HAZARDS ASSOCIATED WITH THE ACTIVITIES AND I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, MY DOG'S INJURY, DEATH, PROPERTY DAMAGE OR LOSS RESULTING THEREFROM.

## **RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT**

4. In consideration of the RELEASEES consenting to my participation in the Activities and permitting my use of their services, property, equipment, and other facilities, and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged, I hereby agree as follows:
- i. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against the RELEASEES AND TO RELEASE THE RELEASEES from any and all liability for any loss, including injury or loss of dog, damage, expense or physical injury, including death DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS LIABILITY ACT, ON THE PART OF THE RELEASEES, AND FURTHER INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF PARTICIPATING IN THE ACTIVITIES REFERRED TO ABOVE;
  - ii. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES for any and all liability for any property damage, loss or personal injury to any third party resulting from my actions or participation in the Activities;
  - iii. This Release Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacity;
  - iv. This Release Agreement and any rights, duties and obligations as between the parties to this Release Agreement shall be governed by and interpreted solely in accordance with the laws of the Province of British Columbia; and
  - v. Any litigation involving the parties to this Release Agreement shall be brought solely within British Columbia and shall be within the exclusive jurisdiction of the Courts of British Columbia.
5. In entering into this Release Agreement I am not relying on any oral or written representations or statements made by, or on behalf of, the Releasees with respect to the safety of participating in the Activities, other than what is set forth in this Release Agreement.
6. If any provision of this Release shall be held by a court of competent jurisdiction to be invalid, unenforceable or void, the remainder of this Release Agreement shall remain in full force and effect.
7. I CONFIRM THAT I HAVE READ AND UNDERSTOOD THIS RELEASE AGREEMENT PRIOR TO SIGNING IT. I AM AWARE THAT BY SIGNING THIS RELEASE AGREEMENT, I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES.
8. I FURTHER ACKNOWLEDGE THAT I AM AT LEAST NINETEEN (19) YEARS OF AGE, MENTALLY COMPETENT AND NOT UNDER ANY FORM OF DURESS OR UNDUE INFLUENCE AT THE TIME OF EXECUTION OF THIS RELEASE AGREEMENT. IF YOU ARE UNDER 19 YEARS OLD WHEN COMPLETING THIS FORM, THE PARTICIPANT MUST GET THE SIGNATURE OF HIS/HER PARENT OR LEGAL GUARDIAN.
