



## Letter of Undertaking

National Amateur Retriever Championship Stake will replace National Retriever Championship Stake when appropriate.

To the Board of Directors of the National Retriever Club of Canada (NRCC)

jointly and severally referred to as the "Host Club", the right and privilege of conducting the 20\_\_ National Retriever Championship Stake, we hereby undertake:

1. To conduct the National Retriever Championship Stake in accordance with the *Retriever Field Trial Rules and Regulations* of the Canadian Kennel Club, the *By-laws of the National Retriever Club of Canada*, and the *Memorandum on Trial Procedures for the National Championship Stakes* found on the National Retriever Club of Canada's website
2. To carry out any instructions received from the National Retriever Club of Canada with respect to the conduct of the trial in so far as these are not in conflict with the rules and regulations of the Canadian Kennel Club.
3. To forward all the documents and reports to the National Retriever Club of Canada Secretary as required in the Retriever Field Trial Rules and Regulations set forth by the Canadian Kennel Club.
4. To open a special bank account under the "Year National or National Amateur" (ie: 2012 National), through which all receipts and disbursements will be processed.
5. To keep proper accounts of all advances, receipts, and disbursements made or incurred in connection with the holding of the National Retriever Championship Stake and to forward the same to the National Retriever Club of Canada before December 31st of the year in which the stake is held.
6. To distribute the National Retriever Club of Canada pins only to those entitled to the same, and to return any surplus pins to the National Retriever Club of Canada.
7. To return any loans made by the National Retriever Club of Canada, trial expenses paid by the National Retriever Club of Canada, as outlined in the Procedures and Guideline for Hosting National Events, as per invoice, and to remit the \$125.00 per running dog fee to the National Retriever Club of Canada on or before the last day of the National.
8. To be responsible (subject to specific provisions herein) for all operating losses and be entitled to any net operating profit resulting from holding of the 20\_\_ National Retriever Championship Stake, the Host Club agrees to indemnify and hold harmless the NRCC from any claims for operating losses or expenses incurred by the Host Club in connection with this stake.
9. To have a suitable liability insurance policy to cover all liability claims arising out of the 20\_\_ National Stake and shall add the NRCC as additional insured.
