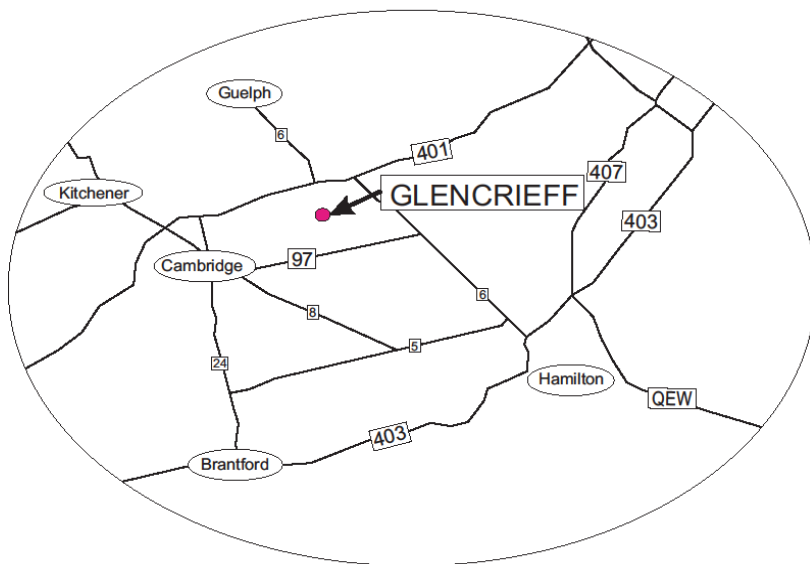

TEST DETAILS:

- Standard CKC rosettes awarded to all qualifying dogs
- Ribbons will be given out at the end of each stake
- Ducks will be used
- Shotguns may not necessarily be used
- Hunt test handlers shall be attired in dark or customary hunting attire.
- Requests refunds will be given for bitches in season. A Veterinarian certificate must be submitted prior to test
- Requests for refunds for injuries sustained after the closing date of test must accompany a letter from a veterinarian and be received before the day of the test
- Recommended arrival time is ½ hour prior to the start time for each stake.

The Labrador Owners Club is a member in good standing with the Canadian National Master Retriever Club. As of July 1, 2010 only passes at Hunt Tests hosted by clubs in good standing of the Canadian National Master Retriever Club are considered in determining eligibility to enter the National Master Hunt Test Stake.

All owners of unregistered, CKC-recognized breeds entering events are required to obtain a *Temporary Competition Number (TCN)*.

TCNs are replacing the current system of entering events with dogs as “listed”, and allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).

- A TCN must be obtained before submitting an entry for an event.
- The same TCN must be used for all event entries for a dog until the dog is permanently registered or has an ERN.
- A TCN cannot be used for Listed Breeds with an MCN (Miscellaneous Competition Number) or dogs that will require a PEN (Performance Event Number) or CCN (Canine Companion Number).

TCNs can be obtained:

- [Online](#) through CKC’s Portal (Note: Individuals who have not yet used the online Portal will be required to create a Portal account before they can submit a TCN application online);
- By submitting a completed [paper application](#) by mail to CKC; or
- By contacting the Shows and Trials Division Toll Free at 1-855-364-7252.

N.S.F. Cheques: There will be a \$25.00 charge for N.S.F. cheques.

Attention Foreign Exhibitors: Only bank drafts or money orders in Canadian funds or personal cheques drawn on a Canadian bank will be accepted. Your understanding and co-operation is appreciated. Thank you.

IMPORTANT NOTE regarding Non-Member Participation Fee (effective January 1, 2011.

An annual non-member participation fee for awards and titles will be charged to a **Canadian non-member of the CKC**. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

Excerpt from the CKC Rules & Regulations for Hunt Tests (section 2.5)

2.5.2: Electronic collars (either dummy or live) as well as prong/pinch type collars shall not be worn by a dog on the grounds of a Hunt Test at any time during the event with the exception of those collars designed to curtail barking which may be worn by a dog while kenneled.

Excerpt from the CKC Rules & Regulations for Hunt Tests (section 3.8)

3.8.1: A judge officiating at a hunt test held under these rules shall not be subjected to any indignities of any kind during the progress of the hunt test. It shall be the duty and obligation of the club holding the hunt test to see that this rule is effectively carried out.

Labrador Owners Club COVID Waiver

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19
